Thank you for your interest in membership in the *La Jolla Beach & Tennis Club*. Please note that we are a non-equity Club and have a current waiting list of three years.

Once your name has been entered on the waiting list, a file is started. To begin the file we request the following:

- Completion of enclosed Membership application.
- A \$500 non-refundable application deposit.

The Club requires a \$100 fee annually, to maintain your place on our waiting list. Our Accounting Department will notify you by mail each year when this amount is due.

Once your application reaches the top of the waiting list, the Club will require the following:

- Three (3) letters of sponsorship/recommendation from current members in good-standing. Letters may not be written by family members or direct business colleagues.
- A family profile outlining professional affiliations, personal and community interests and other Club affiliations and activities.
